This is to bring to your kind knowledge that the Standing Committee of Legal Education Committee of Bar Council of India by virtue of its meeting held on 12<sup>th</sup> September, 2023 considered the matter of Asian International University, Imphal West, Manipur.


After consideration, recognition has been granted to Asian International University, Imphal West, Manipur as per Section 7(1)(i) of the Advocates Act, 1961 for the purpose of conferring the Degrees in Law and also granted fresh approval to its Faculty of Law, Asian International University, Imphal West, Manipur for imparting three year LL.B course, five year BA LL.B course, five year B.Com LL.B course and five year BBA LL.B course with intake of one section of 60 students in each course for a period of two years i.e. for the academic years 2023-24 and 2024-25.

Further, CLE is directed to appoint 7 law teachers, 2 management teachers through proper selection and who shall be paid UGC scale within a period of six months.

Further, CLE is directed to construct 3 rooms as per rules within one year.

(Self financed Universities, Private Universities and deemed to be Universities, private Institutes)**

2. For all self financed Universities, Private Universities and deemed to be Universities, private Institutes, following membership rules shall apply.

  - (ii) For getting membership of AIU the University must be registered under section 2(f) of the UGC Act, 1956.\*\*

  - (v) The annual membership fee shall be Rs 1.50 lakhs (plus GST@18%) for these universities (private, self-financed)
  - (vi) Membership application processing fee shall be Rs.10,000/-(plus GST@18%) (One time)
  - (vii) If the Vice Chancellor or Director of these Institutions is the trustee of the trust/ company/society which runs the University/Institutions and or his/her **near relative** - like son, daughter, father, mother, brother, sister, wife, husband, first cousin, direct-in-laws, direct grand children, direct dependent of member Vice Chancellor/Director he/she will not be permitted to occupy any office in administration of AIU and will not have any voting right.
  - (viii) The Vice Chancellor/Director will be required to give an undertaking on Rs.100/- stamp paper that he is not covered by the term **near relative** as mentioned in sub-section (vii) above.
  - (ix) The University shall be represented by University's Vice Chancellor/Director alone.
